NOTICE IS HEREBY GIVEN TO ALL INTERESTED PERSONS, THAT THE CITY OF BROWNSVILLE, TEXAS, HAS BEEN REQUESTED (AND/OR PROPOSES) TO ADOPT THE FOLLOWING ORDINANCE(S):

Ordinance Number 235-2025-028-S: To request a Specific Use Permit in a Commercial Corridor (CC) zoning district to allow an event center for Lot 1, Block 1, M.G. Estates Subdivision, a resubdivision of M. Samano Partition Wymore Estates Subdivision, Cameron County, Texas, located at 7245 Paredes Line Road, Brownsville, Texas 78521.

Ordinance Number 235-2025-029: To rezone from Residential Single-Family (R-1) to Residential Transition (R-3) to allow a multifamily development for 23.40 acres of land comprised of 5.434 acres out of Block 17 and 17.963 acres out of Block 18, Chicago Gardens Subdivision, Cameron County, Texas, located at 5000 Bowie Road, Brownsville, Texas 78521.

Ordinance Number 235-2025-030-S: To request a Specific Use Permit in a Downtown Core (DC) zoning district to allow a surface parking lot for Lots 7 & 8, Block 56, Original Townsite of Brownsville, Cameron County, Texas, located at 1005 East Levee Street, Brownsville, Texas 78520.

Ordinance Number 235-2026-001: To rezone from Residential Single-Family (R-1) to Residential Suburban (R-2) to allow a duplex for 0.167 acres of land out of Block 21, Chicago Gardens Subdivision, Share 26, Espiritu Santo Grant, Cameron County, Texas, located at 4715 Bowie Road, Brownsville, Texas 78521.

Public Hearing and Action to consider an ordinance of the Brownsville City Commission amending the Unified Development Code (UDC), Article 4 - Zoning Regulations, Section 4.4.4 - Additional Use Standards, Subsection 12 - Bars or Drinking Establishments, by incorporating regulation parameters for uses where there is on-premise consumption of alcoholic beverages or spirits; and dealing with related matters.
