

NOTICE OF A SPECIAL MUNICIPAL RUNOFF ELECTION
TO BE HELD BY THE CITY OF BROWNSVILLE, TEXAS

TIME AND PURPOSE OF ELECTION: The City of Brownsville, Texas (the “City”) will hold a Special Municipal Runoff Election between the hours of 7:00 A.M. and 7:00 P.M. on Saturday, June 7, 2025, in the City for the purpose of electing a City Commissioner At-Large “B” and a City Commissioner District 4. No candidates for Commissioner At-Large “B” and, Commissioner District 4, received a majority of the votes cast at the General Municipal Election held on May 3, 2025. Therefore, a Special Municipal Runoff Election is required.

PLACE OF ELECTION: For the purpose of holding said election, the early voting by personal appearance shall be conducted by the Cameron County Elections Administrator at five (5) locations in Brownsville, Texas, beginning on Tuesday, May 27, 2025, and ending on Tuesday, June 3, 2025, or for such additional days as provided by law (locations and sites are subject to change based on the discretion of the Election Administrator).
