## NOTICE OF ORDINANCES CITY OF STARBASE

The City of Starbase held City Commission meetings and public hearings on Thursday, May 29, 2025, at 9:00 a.m. and Friday, May 30, 2025, at 9:00 a.m. at the temporary City Hall located at 39046 L B J Boulevard, Brownsville, TX 78521. The following ordinances were approved and adopted by the Starbase City Commission. The Ordinances below are effective on this date of publication. Copies of Starbase ordinances are available on the City website.

- 1. An Ordinance of the City of Starbase Creating the Position of an Administrative Officer of the City To Serve at the Will of the City Commission of the City of Starbase Texas and Providing that such person is to be compensated as directed by the Mayor and the City Commission of Starbase, Texas and Providing Duties of the Administrative Officer and providing for a penalty not to exceed five hundred dollars (\$500.00) for each offense;
- 2. An Ordinance of the City of Starbase, Texas, Adopting the 2015 International Building Code promulgated by the International Code Council as the building code including Appendices C, E, F, G, H, I, J, and K and providing for a penalty not to exceed two thousand dollars (\$2,000) for each offense:
- 3. An Ordinance of the city of Starbase, Texas, adopting the 2015 International Residential Code for one- and two-family dwellings and Appendices AE, AH, AI, AJ, AK, AM, and AP promulgated by the International Code Council as the Residential Code Ordinance and providing for a penalty not to exceed two thousand dollars (\$2,000) for each offense;
- 4. An Ordinance of the city of Starbase, Texas, adopting the 2015 International Energy Conservation Code promulgated by the international code council as the energy code and providing for a penalty not to exceed two thousand dollars (\$2,000) for each offense;
- 5. An ordinance of the City of Starbase, Texas, adopting the 2015 International Fire Code promulgated by the International Code Council as the fire code; and providing for a penalty not to exceed two thousand dollars (\$2,000) for each offense;
- 6. An Ordinance of the City of Starbase, Texas, adopting the 2015 International Mechanical Code promulgated by the International Code Council as the Mechanical Code Ordinance; and providing for a penalty not to exceed two thousand dollars (\$2,000) for each offense;
- 7. An ordinance of the City of Starbase, Texas, adopting the 2015 International Plumbing Code promulgated by the International Code Council as the Plumbing Code Ordinance; and providing for a penalty not to exceed two thousand dollars (\$2,000) for each offense;
- 8. An ordinance of the city of Starbase, Texas, adopting the 2018 International Swimming Pool and Spa Code promulgated by the International Code Council as the Swimming Pool and Spa Code Ordinance; and providing for a penalty not to exceed two thousand dollars (\$2,000) for each offense;
- 9. An Ordinance of the City of Starbase, Texas, adopting the 2014 National Electric Code approved by the National Fire Protection Association, Inc. as the Electrical Code Ordinance; and providing for a penalty not to exceed two thousand dollars (\$2,000) for each offense;
- 10. An Ordinance of the City of Starbase, Texas, Adopting Extended Hours for the sale of mixed beverages and the sale and delivery of malt beverages and wine for TABC licensees or permittees holding a Retailer Late Hours Certificate; and providing for a penalty not to exceed five hundred dollars (\$500) for each offense;
- 11. An Ordinance of the City of Starbase, Texas, adopting the Texas Food Establishment Rules regulating food service establishments, retail food stores, temporary food establishments, mobile food units, roadside food vendors, and farmers' markets; and providing for a penalty not to exceed five hundred dollars (\$500) for each offense;
- 12. An Ordinance of the City of Starbase, Texas, establishing a Comprehensive Emergency Management Program; authorizing the Appointment of an Emergency Management Coordinator; providing for the duties and responsibilities of the Emergency Management Director and Coordinator; Authorizing Mutual Aid Agreements with other Governmental Entities; creating an offense for violating the city's emergency management plan; and providing for a penalty not to exceed one thousand dollars (\$1,000) for each offense;
- 13. An Ordinance of the City Commission of the City of Starbase, Texas, Adopting into its Code of Ordinances this Ordinance entitled "Nuisances" pursuant to Texas Local Government Code Chapters 214 and 217, Texas Health and Safety Code Chapter 341, Texas Transportation Code Chapter 683, and other law, which Ordinance shall govern the definition and existence of Nuisances in the City, the remediation of same, and general standards by which property within the City will be kept and maintained; and providing for a penalty not to exceed two thousand dollars (\$2,000) for each offense.
