

# NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.111809 per \$100 valuation has been proposed by the governing body of Texas Southmost College.

PROPOSED TAX RATE	\$0.111809 per \$100
NO-NEW-REVENUE TAX RATE	\$0.108821 per \$100
VOTER-APPROVAL TAX RATE	\$0.111809 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for Texas Southmost College from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that Texas Southmost College may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Texas Southmost College is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 28, 2025 AT 5:30PM AT GORGAS BOARD ROOM, 80 FORT BROWN, BROWNSVILLE, TX 78520.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Texas Southmost College is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the of Texas Southmost College at their offices or by attending the public hearing mentioned above.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by Board of Trustees last year to the taxes proposed to be imposed on the average residence homestead by Texas Southmost College this year.

Total tax rate (per \$100 of value)	\$0.115117	\$0.111809	decrease of -0.003308 per \$100, or -2.87%
Average homestead taxable value	\$147,929	\$161,465	increase of 9.15%
Tax on average homestead	\$170.29	\$180.53	increase of 10.24, or 6.01%
Total tax levy on all properties	\$23,734,759	\$24,764,359	increase of 1,029,600, or 4.34%
