

NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$0.55 per \$100 valuation has been proposed by the governing body of the City of Starbase, Texas.

PROPOSED TAX RATE	\$0.55 per \$100
NO-NEW-REVENUE TAX RATE	N/A per \$100
VOTER-APPROVAL TAX RATE	N/A per \$100

The no-new-revenue tax rate is the tax rate for the 2026 tax year that will raise the same amount of property tax revenue for the City of Starbase from the same properties in both the N/A tax year and the 2026 tax year.

The voter-approval tax rate is the highest tax rate that City of Starbase may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that City of Starbase is not proposing to increase property taxes for the 2026 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 11, 2025 at 7:00 pm at Temporary City Hall located at 39046 LBJ Boulevard Brownsville, Texas 78521.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, City of Starbase is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City Commission of City of Starbase at their offices or by attending the public meeting mentioned above.

Property tax amount = (tax rate) x (taxable value of your property) / 100

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.
