

REQUEST FOR QUALIFICATIONS

The South Texas Health Cooperative is now accepting Qualification Statements for:

Employee Managed Health Insurance Consulting Services RFQ #HC-2026-03

The South Texas Health Cooperative (“STHC”) is extending its original RFQ #HC-2026-03 notice to request Qualification Statements for the purpose of selecting a Highly Qualified firm to provide Health Insurance Consulting Services. Services are to include, but are not limited to, assisting STHC with all aspects of planning, design, and budgeting for our Group Medical Coverage beginning with the 2026-2027 plan year. The successful consulting firm will be retained to assist for the next five (5) years. The firm shall be duly licensed to perform required services in and by the State of Texas. It is the intent to solicit qualification statements from firms which can provide the entire scope of services as further defined in the bid documents.

To qualify for consideration, all information regarding your firm’s qualifications must be submitted in one (1) package and addressed as indicated below in accordance with the requirements set forth in the RFQ packet.

The South Texas Health Cooperative was established in August 1999 and currently serves the La Feria Independent School District and the Rio Hondo Independent School District to provide uniform benefits, including Health, Life, and Dental, to the eligible employees of their respective districts. The employee benefits are provided to full-time personnel as per each District’s definition of full-time personnel, and their eligible dependents as defined by the Plan underwriter for the participating school districts.
